2019 Corporate Passes

Corporate Passes are ideal for those companies looking to bring out more than four players on any given day. Up to 12 passes per pass-holder may be used on any day, and upwards of 12 may be authorized at the discretion of the Head Professional. As a result, passes offer the greatest freedom of distribution and booking for a pass-holder's clients and customers. First time corporate pass-holders are required to purchase four shares and a corporate initiation fee.

- Allows two individuals to be named as authorized bookers for call-in or walk-up times
- Through online booking, login details can be shared by the owner/authorized bookers; in this way, any corporate has the ability to self-authorize as many individuals as they wish for online booking
- Remaining passes can be tracked via online booking profile
- Within the three packages, additional passes may be purchased in increments of 10 at any time in the season. Upgrades to a higher package may be done before June 30
- For pass-holders with riding privileges, each pass will include a 1/2 power cart rental
